NO ACTION IS REQUIRED BY SENIOR NOTEHOLDERS

GENERAL BACKGROUND

Wilmington Trust Company (the “Trustee”) is successor indenture trustee under that certain indenture dated as of September 1, 1987, as amended, supplemented or modified (the “Indenture”), between Lehman Brothers Holdings Inc. (formerly known as Shearson Lehman Brothers Holdings Inc.) (“LBHI”) and Wilmington Trust Company (as successor trustee to Citibank, N.A. (the “Predecessor Trustee”)). Under the Indenture, LBHI issued certain senior debt securities (the “Senior Notes”). Each such Senior Note is identified by a unique alphanumeric sequence known as a “CUSIP number.” Holders of the Senior Notes are referred to herein as the “Senior Noteholders.”

On September 15, 2008, and at various times thereafter, LBHI and certain of its affiliates commenced cases under chapter 11 of the United States Bankruptcy Code (the “Bankruptcy Cases”). LBHI and its affiliates that filed bankruptcy proceedings in the United States are referred to herein as the “Debtors.”

A summary of facts relating to confirmation of the Debtors’ plan and previous distributions to the Senior Noteholders follows. Senior Noteholders may also refer to the previous notices issued by the Trustee, which are available on the website maintained by the Trustee at www.wilmingtontrust.com/lehman.

CONFIRMATION OF DEBTORS’ PLAN

On December 6, 2011, the Bankruptcy Court entered an Order [docket no. 23023 at www.lehman-docket.com] confirming the Debtors’ Modified Third Amended Joint Chapter 11 Plan (the “Plan”) [docket no. 22973 at www.lehman-docket.com]. The Senior Noteholder Claim is classified as a “Class 3” claim consisting of “Senior Unsecured Claims against LBHI.” On March 6, 2012, the Plan was deemed effective by the Debtors.

In connection with the effectiveness of the Plan, the original CUSIP number for each Senior Note was replaced by a corresponding “replacement CUSIP.” The original CUSIP number and corresponding replacement CUSIP number for each Senior Note are listed on Exhibit A.

PREVIOUS PLAN DISTRIBUTIONS TO SENIOR NOTEHOLDERS

Beginning in April 2012, the Debtors have made nineteen semiannual distributions of cash under the Plan to the Trustee on behalf of Senior Noteholders, and three special distributions on June 16, 2016, December 7, 2017 and July 18, 2019 (the “Previous Plan Distributions”). The Previous Plan Distributions are described more fully in notices that the

Trustee provided to Senior Noteholders in connection with each Previous Plan Distribution. The aggregate amount of distributions to the Trustee on behalf of Senior Noteholders under the Previous Plan Distributions, after the deduction of amounts payable to the Trustee through exercise of the Trustee's charging lien, was \$22,666,790,477.41,¹ and constituted 46.409090% of the total allowed amount of the Senior Noteholder Claim.²

DISBURSEMENT OF FEE RESERVE

Pursuant to Section 6.7 of the Plan, the Debtors agreed to pay the Trustee, in its capacity as a member of the Official Committee of Unsecured Creditors ("Creditors' Committee") and as an indenture trustee, its reasonable fees and expenses (including attorneys' fees and expenses), including fees and expenses that accrued before the Effective Date of the Plan. The United States Trustee objected to the payment by the Debtors of the fees and expenses of the Trustee and other members of the Creditors' Committee under Section 6.7 of the Plan (the "U.S. Trustee Objection").³

The Bankruptcy Court, by its memorandum decision dated February 15, 2013 (the "Memorandum Decision"), and its order dated May 31, 2013 (the "Fee Order"), overruled the U.S. Trustee Objection and approved payment of the Trustee's reasonable fees and expenses in accordance with the Plan.⁴ The Trustee received payment of pre-Effective Date amounts from the Debtors under the Fee Order in the amount of \$12,119,250.20 ("Disputed Fee Payment"). The Trustee deposited the amount of the payments received from the Debtors under the Fee Order that were subject to the U.S. Trustee Objection and certain other fee disputes with the Debtors (collectively, the "Fee Dispute") in an account for the benefit of the Senior Noteholders (the "Fee Reserve") pending final resolution of the Fee Dispute. Additionally, the Trustee exercised its charging lien in the total amount of \$14,857,862.00 ("Charging Lien Amounts") in connection with three prior distributions to Senior Noteholders (as described in the notices regarding the Prior Plan Distributions dated April 11, 2012, September 25, 2012, September 30, 2014) to ensure reimbursement of the Trustee's reasonable fees and expenses (including attorney's fees) if the Trustee were forced to disgorge the Disputed Fee Payment to the Debtors due to the United States Trustee prevailing in the Fee Dispute. The Charging Lien Amounts were also deposited into the Fee Reserve.

On March 1, 2013, the United States Trustee appealed the Bankruptcy Court's decision (the "U.S. Trustee Appeal") to the United States District Court for the Southern District of New York (the "District Court").⁵ On March 31, 2014, the District Court issued its opinion and order vacating the Bankruptcy Court's decision and remanding to the Bankruptcy Court for further proceedings (the "District Court Decision").⁶ The Creditors' Committee members sought leave to appeal the

District Court Decision as an interlocutory order but the District Court denied leave to appeal.⁷ As part of remand proceedings in the Bankruptcy Court to determine whether the fees and expenses of the Trustee and other Creditors' Committee members could be paid under the "substantial contribution" standard of Section 503(b) of the Bankruptcy Code, the Trustee and certain other members of the Creditors' Committee (collectively, "Applicants") filed an amended omnibus application and related court papers seeking payment of a portion of their respective fees and expenses as an administrative expense under the substantial contribution standard (the "Amended Application").

Pursuant to a Settlement Agreement, dated November 7, 2017 (the "Settlement Agreement"), between the Debtors, the Trustee and the other Applicants, the parties settled the Fee Dispute. Pursuant to the Settlement Agreement, the Trustee was permitted to retain \$6,280,968.10 from the Disputed Fee Payment in payment of its fees and expenses set forth in the Amended Application, but was obligated to return \$5,638,487.90 of the Disputed Fee Payment to the Debtors. After giving effect to the payments permitted under the Settlement Agreement, and after reimbursement of the remainder of the Trustee's pre- and post-Effective Date reasonable fees and expenses (including attorney's fees), which includes the Trustee's reasonable fees and expenses incurred in the litigation of the Fee Dispute, the Fee Reserve holds \$7,043,678.19.

TWENTY-THIRD PLAN DISTRIBUTION TO SENIOR NOTEHOLDERS

As indicated in the Debtors' Notice dated September 30, 2021 (the "Twenty-Third Distribution Notice"),⁸ the amount to be distributed will constitute **0.063903%** of the total allowed amount of the Senior Noteholder Claim. The calculation of the initial distribution to Senior Noteholders under the Plan results in an aggregate cash amount of \$31,224,718.47. The cumulative distributions made by the Debtors to the Trustee on behalf of the Senior Noteholders will constitute 46.472993% of the total allowed amount of the Senior Noteholder Claim.

Additionally, given the final resolution of the Fee Dispute, the Trustee has determined that the Fee Reserve should be released for the benefit of the Senior Noteholders. Pursuant to Section 607 of the Indenture, the Trustee has decided to exercise its charging lien to retain \$506,495.88 of the Fee Reserve to reserve for future reimbursement of its reasonable fees and expenses (including attorneys' fees) that may come due. After deduction of this retained amount, the release of the Fee Reserve results in an additional distribution of \$6,537,182.31 from the Fee Reserve to the Senior Noteholders (the "Fee Reserve Distribution").⁹ Thus, the aggregate amount of the twenty third distribution to Senior Noteholders under the Plan, after inclusion of the Fee Reserve Distribution, and after application of rounding adjustments, is \$37,761,830.84 (the "Twenty-Third Plan Distribution").

Exhibit A reflects distribution amounts and distribution rates calculated according to embedded formulas for each Senior Note provided to Wilmington Trust by the Debtors. Exhibit A sets out for each Senior Notes CUSIP number, among other things, with respect to the Twenty-Third Plan Distribution: (i) the aggregate distribution amount allocable to such CUSIP number; and (ii) the unrounded cash per \$1,000 principal amount or per unit of Senior Notes (the "Rate") applicable to such CUSIP number.¹⁰ Senior Noteholders may calculate the amount of their individual portion of the Twenty-Third Plan Distribution as follows: (i) for those Senior Notes denominated in *dollar amounts* on Exhibit

Nevertheless, the Debtors have disputed their obligation to continue payment of the Trustee's reasonable fees and expenses, and the Trustee is exercising its charging lien in case the Debtors do not pay future amounts due to the Trustee.

A, by dividing the principal amount of the Senior Notes that they hold by 1000 and multiplying the resulting number by the applicable Rate, or (ii) for those Senior Notes denominated in *units* on Exhibit A, multiplying the number of units of such Senior Notes that they hold by the applicable Rate.

A sample calculation of the individual distribution amount for each type of Senior Note is included below:¹¹

1. For Senior Notes denominated in dollars:

Example: 10,000 principal amount (Senior Note CUSIP number 5252M0BZ9) / 1000 = 10
10 x 0.778975 (CUSIP number 5252M0BZ9 Rate-last column) = \$7.79 (amount of Twenty-Third Plan Distribution)

2. For Senior Notes denominated in units:

Example: 100 Units (Senior Note CUSIP number 52522L558) =
100 x 0.021043 (CUSIP number 52522L558 Rate-last column) = \$2.10 (amount of Twenty-Third Plan Distribution)

NO ACTION IS REQUIRED BY SENIOR NOTEHOLDERS TO RECEIVE THEIR PORTION OF THE TWENTY-THIRD PLAN DISTRIBUTION. THE TWENTY-THIRD PLAN DISTRIBUTION WILL BE DEPOSITED IN THE ACCOUNTS IN WHICH SENIOR NOTEHOLDERS HOLD SENIOR NOTES. NO CHECKS WILL BE ISSUED.

After the Twenty-Third Plan Distribution, the Debtors will make distributions of available cash in accordance with the Plan semi-annually within five (5) business days of March 30 and within five (5) business days of September 30 of each year,¹² provided the aggregate distribution is not less than \$10,000,000.00. The Debtors have provided information regarding distributions under the “Distribution and Claims Information” tab of their website at www.lehman-docket.com.¹³
